Teeth Whitening Consent Form

Overview & Expectations

I understand that the results cannot be guaranteed as teeth whiten differently for each individual. If you have grayish teeth, teeth may become a lighter shade of gray but will not change to a white shade. I also understand that this procedure and home care treatment are not intended to whiten artificial teeth, caps, crowns, teeth with fillings, veneers or porcelain, composite, other restorative materials or tetracycline stains. I understand that the longevity of my whitening results will vary based on the types of food and drink that I consume, brushing habits, and other daily maintenance. I understand that if any sensitivity occurs that it should only be temporary. I understand that I may see some blanching on my gums after using the product, which is a normal reaction to hydrogen peroxide; it will only be temporary and generally passes before leaving the studio. Use of the product is not recommended for children under 14 or for women that are pregnant or breastfeeding. It is also not recommended for anyone with periodontal disease or gingivitis as this can contribute to increased sensitivity.

I UNDERSTAND THAT IF ANY OF THE 8 STATEMENTS BELOW APPLY TO ME OR IF I AM UNSURE IF THEY APPLY TO ME, THAT I SHOULD **CONSULT MY DENTIST BEFORE CONTINUING WITH A TEETH WHITENING PROCEDURE:**

- Do you have a severe gag reflex?
- Are you prone to gum sensitivity?
- Do you have sensitivity to sunlight or other forms of direct light?
- Are you taking any medications that increase your sensitivity to sunlight or to other forms of direct light?
- Do you wear braces or have loose crowns, broken or fractured teeth, unfinished dental work or grayish teeth as a result on tetracycline?
- Have you had any oral surgery or extractions within the last 60 days?
- Do you have existing tooth decay, untreated gingivitis or periodontal disease?
- Are you allergic to any of the following ingredients? **IF SO, DO NOT USE THIS PRODUCT**
 - Silicone Mouth Tray (latex free). (If allergic to Silicone **avoid treatment**)
 - Carbamide Peroxide, Menthol, Mint Flavoring, Propylene Glycol, Kosher Glycerin, Triethanolamine. (If allergic to any ingredients **avoid treatment**)
 - Cotton, Soybean oil, and Vitamin E. (Our Vitamin E is soy based, if you are allergic to soy or any other ingredients **avoid use of swab**)

Instructions after using the Product:

I will be required to refrain from consuming any substances that could discolor my teeth for the first 48 hours after treatment. These substances include: coffee, teas, and colas, ALL tobacco products, mustard or ketchup, red wine, soy sauce, berries, berry pie, and red sauces. I understand I should avoid eating or drinking any dark liquids or foods and/or smoking within 24 hours after the treatment(s).

REFUND POLICY:
